Farewell, Fine Fellow... J. William Middleton Retires

J. William Middleton retires from the Garrett-Jacobs Mansion Endowment Fund Board as a Trustee after 15 years of service. In Bill's own words, "I was asked by Pierce Linaweaver and Jack Gillette both of whom were GJMEF Board members and past Engineers Club presidents to join the Foundation board. I felt honored to be asked by them. In addition, I very much like history and Baltimore. The Foundation gave me the opportunity to do both. It was a real pleasure to work with other members of the Board and The Engineers Club in making the Mansion, a national treasure, available to the citizens of Baltimore."



Bill served the GJMEF with insight, business acumen, and gentle humor. He was unfailingly cordial and respectful in his dealings with everyone. He brought more than 50 years of banking experience in the Mid-Atlantic area. He was President of Equitable Bank for the last five years of his 25-year tenure. He was Managing Director at Evergreen Capital, LLC., an investment banking firm providing services to entrepreneurs of privately-held middle-market companies through the Mid-Atlantic region. Prior to Evergreen Capital, Bill was a director at Mason Dixon

Bancshares, Inc., Bank of Maryland. He joined the Board of CFG Community Bank in June 2010 with a passion for helping to create a significant, locally-based community bank to serve the banking needs of the Baltimore business community.

Robert Schaefer, who was the Executive Director of the France-Merrick Foundation in Baltimore from 1996 to 2013, crossed paths with Bill a number of times. Bob stated that knowing Bill was "generally in regard to his tireless fundraising efforts for the Garrett-Jacobs Mansion's restoration which France-Merrick Foundation supported, since historic preservation was one of its focuses." Bill serves on the boards of Glen Meadows Foundation, Presbyterian Eye, Ear, and Throat Charity Hospital, and Professional Advocate, a provider of liability insurance to the healthcare community. He has served as Chairman of the Board of McDonogh School, the Better Business Bureau of Baltimore, March of Dimes, and many other community organization boards. 
